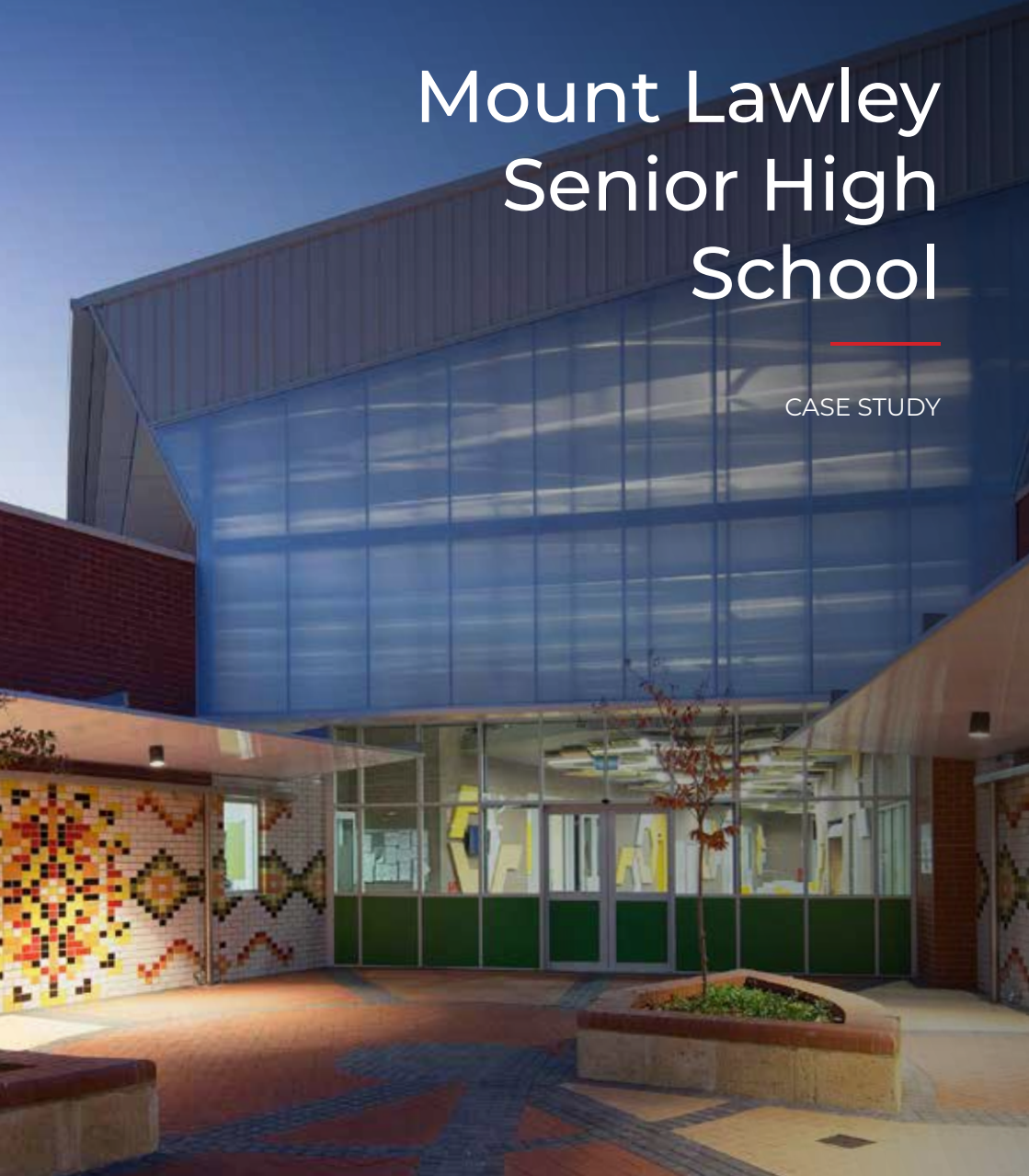

Enhanced Web Security and Granular Control

Education focused security solution

Mount Lawley Senior High School, located in the Swan Education District, is one of the premier schools in Western Australia. The school has introduced many innovative ways of using Information Technology to engage its 1,800 students and enhance the teaching and learning processes.



The Challenge

The school was a proud early adopter of a digital learning environment and to successfully embrace this, it was vital for their students and teachers to access the school network. This significantly increased the demand on the school's Internet resources and the requirement to protect their staff, students and network from online risks.

Their existing solution provided limited capabilities to effectively filter web activity to ensure only appropriate, relevant and secure website content could be accessed. In addition it was not possible for the ICT team to apply data quotas to manage excessive data consumption of students.
